

Salon dispute moves to court

Julia Stewart, the owner of "The Loft Hair Designs" salon in downtown Nashville, has filed a lawsuit in Chancery Court against rival salon manager Marci Blaylock and former employee Troylynn Brackenbury.

Stewart alleges competitor Blaylock, owner of "Plush" salon just three blocks away, coerced Brackenbury into breaching her contract with Stewart through the unlawful appropriation of The Loft's client database.

Brackenbury was a five-year employee of The Loft Hair Designs, serving as an office manager since 2002. She left the salon for "Plush" in May, and as Stewart soon discovered through several loyal patrons' remarks, she allegedly took with her The Loft's "client cards" that held the contact information of every customer that had patronized the salon. Both Brackenbury and Blaylock are charged with violating the "non-competition" agreement signed by Brackenbury upon her employment with The Loft.

Neither defendant could be reached for comment.
